Dear Sir,

This is to inform you that as per NSDL & CDSL weekly report received from our Registrar & Share Transfer Agent (RTA) for the last trading week ended on 08-04-2022, we came to know that one of the Promoter Group Company namely 'Bihar State Industrial Development Corporation Limited' (BSIDC) has sold 98,280 (0.11%) equity shares of the Company during the above said week, without any intimation to the Company. Now its residual shareholding is 64,17,463 (7.11%) equity shares as on 08-04-2022.

This is violation of Regulation 7(2)(a) of the SEBI (Prohibition of Insider Trading) Regulations, 2015 and Company's Insider Code of Practice as approved by the Board of Directors as per SEBI/Listing norms. The above said trading was made incidentally during the trading window closure. In this regard, a notice is being sent to the above Company for providing its reply.

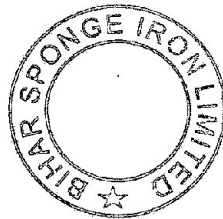
